ORDER

As decided in the discussion held on 22.12.98 with the representatives of the Kerala State Library Council and the Thiruvananthapuram Public Library, the following Guidelines for the conduct of the C.L.I.Sc course in the Thiruvananthapuram Public Library and the Kerala State Library Council are ordered.

1. The Registration fee is enhanced to Rs. 25/-
2. The tuition fee is enhanced to Rs. 150/-
3. The Caution Deposit is enhanced to Rs. 200/-
4. Enhancement of Exam fee to Rs. 50/-
5. The SC/ST Students be exempted from payment of fees on items 1,2 and 4 above.
6. The reservation of three seats in the LLA quota in the Thiruvananthapuram Public Library is stopped and seats so obtained is apportioned in the ratio 2:1 to the category of (1) candidates in Kerala Ministerial subordinate Service and (2) Atender other than those beings to Kerala Ministerial Subordinate Service.

The unfilled seats if any in the category Nos. 4,5 and 6 will be apportioned in the ratio 2:1 to the category Nos. 2 and 3 respectively.

The approved syllabus for the CLISc course is appended. Minor charges in the Syllabus can be affected by the State Librarian and Secretary, Kerala State Library Council after mutual consultation.

The duration of the course will be six months with minimum practical hours of 100 to be conveniently dispersed by the concerned institution. Two course are to be scheduled in a year; first from January to June and second from it July to December.

The expenditure on this account in respect of TPL will be met from the Head of account 2205-00-105-96-NP and 2205-00-105-97-34 plan in the current year's budget. In the case of Kerala State Library Council the expenses will be met from its Establishment and Organization expenses.
