S. R. O. No. 711/2006.—In exercise of the powers conferred by sub-section (1) of Section 2 of the Kerala Public Service Act, 1969 (19 of 1968), the Government of Kerala hereby make the following rules further to amend the Kerala State Central Library Subordinate Service Rules, 2003, issued by notification under G. O. (P) No. 162/2003/H. Edn. dated the 13th November, 2003 and published as S. R. O. No. 1210/2003 in Part I of the Kerala Gazette No. 51 dated the 30th December, 2003 namely:—

RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala State Central Library Subordinate Service (Amendment) Rules, 2006.

(2) They shall come into force at once.

2. *Amendment of the Rules.*—In the Kerala State Central Library Subordinate Service Rules, 2003, in Rule 6, the existing notes below Category 2, Librarian Grade III, the following notes shall be substituted namely:—

“Notes:—(1) In a unit of four vacancies, the following will be the order of rotation:—

- (i) By promotion from Librarian Grade IV of the Kerala State Central Library Subordinate Service with Degree in any subject and Degree in Library and Information Science.
- (ii) Direct recruitment.
- (iii) By promotion from Librarian Grade IV of the Kerala State Central Library Subordinate Service with S. S. L. C. and Diploma in Library Science or Certificate in Library Science.
- (iv) Direct recruitment.

(2) In case qualified personnel are not available for promotion those vacancies shall also be filled up by direct recruitment.

(3) Three separate seniority lists of Grade IV Librarians having the qualification of Degree, Diploma and Certificate in Library Science shall be maintained so as to provide promotion to the senior most person in each category to the post of Librarian Grade III against the separate quora".

Explanatory Note

(This does not form part of the notification but is intended to indicate its general purport).

The Kerala Public Service Commission has pointed out that in the Kerala State Central Library Subordinate Service Rules, 2003 issued as per G O. (P) 162/2003, H. Edn. dated the 13th November, 2003 in the note under category 2 in rule 6, there exists some ambiguity in the definition of the order of rotation in a unit of four vacancies as explained therein. In order to avoid the ambiguity in the said orders the note under category 2 is modified.

The notification is intended to achieve the above object.
